General Rule 7: Each exhibitor must exhibit, in the show and premium sale, his or her own animal unless sick, has more than one (1) animal in the class or is excused by the Lincoln County Fair Board. The only time the exhibitor may be excused is in the event of a family emergency, medical emergency or a state qualifying school event. (Case by case instance presented to the fair board by exhibitor & guardian).
